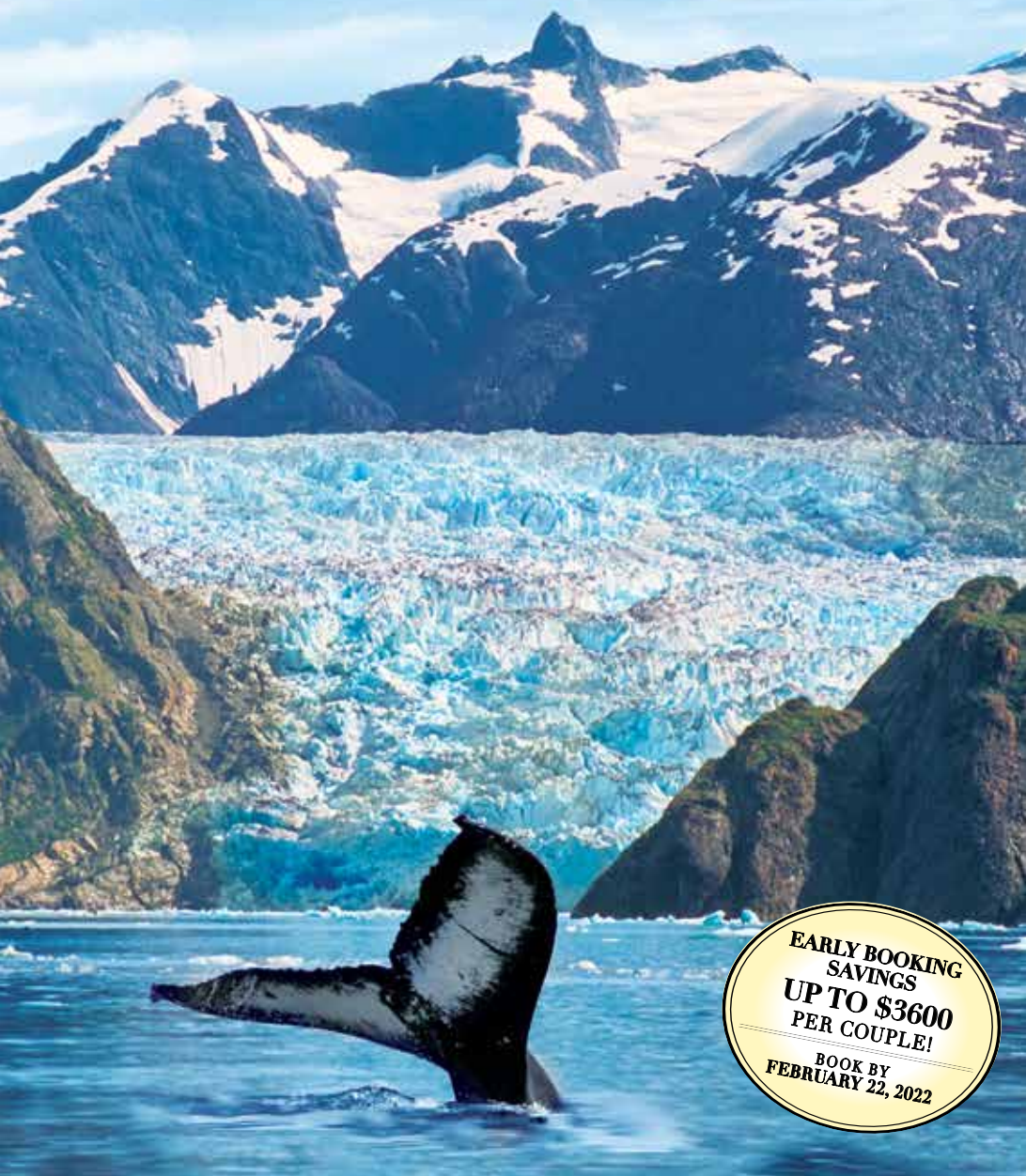

Moderate pace, greater distances covered, walking over uneven surfaces and some stair climbing and embarking and disembarking Zodiac watercraft.



CHALLENGING

Vigorous pace, frequent movement, extensive walking over uneven surfaces, hiking and stair climbing and embarking and disembarking Zodiac watercraft.

Exploring the Inside Passage

Shaped by the Ice Age and sheltered from the Pacific Ocean by one thousand miles of islands lining North America's Pacific Coast, the Inside Passage renders untamed Alaska a picturesque panorama of magnificent glaciers, snowcapped mountains and pristine wilderness. Stand on the deck of our Five-Star, all-Suite small ship as you cruise protected cliff-rimmed fjords and inlets of serene waters. Watch for wildlife such as bald eagles, harbor seals, humpback whales and brown bears. See the thunderous calving of the Dawes and South Sawyer Glaciers, venture into narrow Tracy Arm Fjord and Endicott Arm Fjord and explore the Passage's hidden treasure—seldom-visited Elfin Cove. Along the way, encounter the indigenous culture of the Tlingit, onion-domed churches built by Russian fur traders, quirky fishing villages, trading outposts settled by American pioneers and Gold Rush settlements built over a century ago.

Ketchikan

Backed by the forested slopes of Deer Mountain, the fishing town of Ketchikan is the “salmon capital of the world.” Stroll the Gold Rush-era boardwalks of Creek Street and watch spawning salmon swimming upstream through the middle of town along the well-known “Salmon Ladder.” A rich profusion of Haida, Tlingit and Tsimshian

arts harmonize the town’s cultural facets. See the art of Potlatch Totem Park, where a master craftsman demonstrates the ancient technique of hand-carving a totem pole.

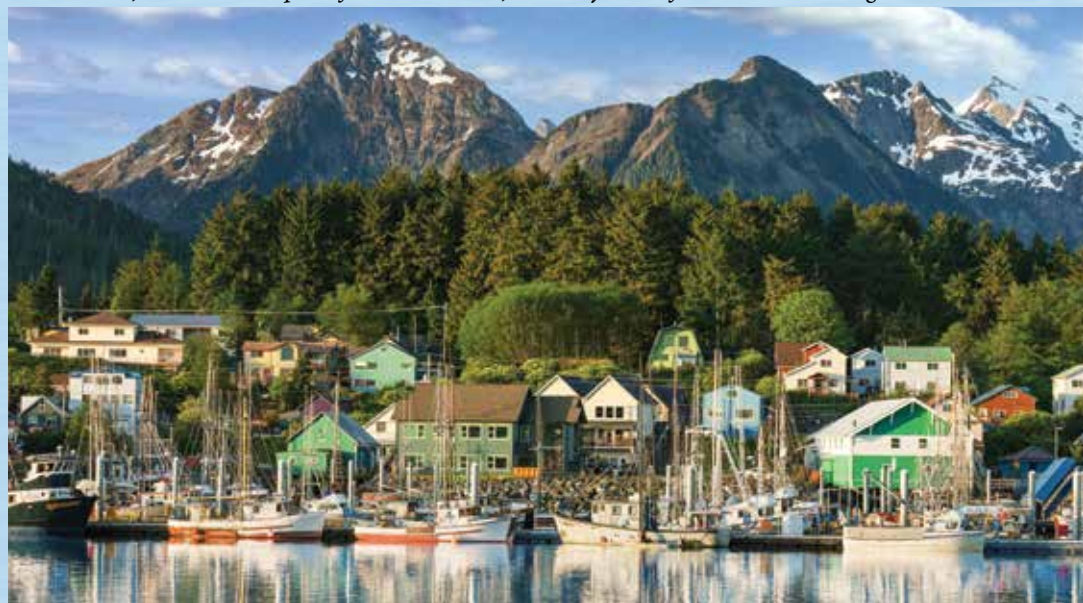
Wrangell

Seldom-visited Wrangell, known as the “Gateway to the Stikine River,” is the only Alaskan town to have flown the flag of three nations—Russia, Great Britain and the United States. A Tlingit stronghold for thousands of years, Wrangell was established as a fur-trading post by the Russians in 1843, making it one of Alaska’s oldest non-native settlements. Famed naturalist John Muir used Wrangell as a base for his exploration of southeast Alaska, and lawman Wyatt Earp briefly served as its marshal during the Klondike Gold Rush. Tlingit culture abounds in this charming fishing village, which is today home to more than a dozen colorful totem poles.

Sitka

Nestled on the edge of Baranof Island, Sitka penetrates one of Alaska’s most stunning regions and proudly displays

Until 1867, Sitka was the capital of Russian America, and today is one of Alaska’s most alluring and historic towns.

its indigenous and Russian history. The town flourished as a Russian fur trading hub until its 1867 transfer to the United States.

Visit the Alaska Raptor Center, Alaska's foremost bald eagle habitat, where more than 100 injured eagles are rehabilitated and released each year. Explore the Tlingit culture while conversing with local artisans in Sitka National Historical Park, where trails are lined with totem poles—a lasting tribute to the ancient artform. Marvel at the collection of icons in St. Michael's Cathedral, North America's first Russian Orthodox church.

Elfin Cove/Point Adolphus

Go ashore to explore pristine Chichagof Island and visit the small fishing community of Elfin Cove. Situated across from Glacier Bay National Park and with only 20 permanent residents, this hamlet comes alive in summer, attracting fishing enthusiasts. Back aboard the ship, from the observation deck, search for humpback whales and orcas feeding in the nutrient-rich waters of Point Adolphus while cruising through Icy Strait, where tidal waters teem with marine life. Watch for sea lions and bald eagles who frequent these waters, baited by the salmon swimming in abundance.

Tracy Arm Fjord/ South Sawyer Glacier/ Endicott Arm Fjord/Dawes Glacier

Cruise between near-vertical rock walls into the deep and narrow fjord of Tracy Arm, where waterfalls cascade from bluffs, forests fade to sheer rock and icebergs glint in the glistening summer sunlight. At the remote end of Tracy Arm, listen to ice calving off the soaring South Sawyer Glacier. Venture to the edge of Dawes Glacier aboard Zodiacs in the Endicott Arm Fjord.

Juneau

Only accessible by air or sea, the Alaskan state capital, Juneau, is where *The Call of the Wild* author Jack London set forth to join the Klondike Gold Rush in 1897.

Vancouver ♦ Victoria Pre-Program Option

Surrounded by water on three sides, Vancouver is the coastal jewel of the Pacific Northwest. British Columbia's largest city, Vancouver's vibrant cosmopolitan atmosphere—rich in art and culture gleaned from the indigenous people of the Pacific Northwest and Alaska—forms a spectacular city. Visit Vancouver Island and famous Butchart Gardens. Tour elegant Victoria, a former British Empire port that still retains a charming English accent as well as wonderfully restored 19th-century architecture.
